LEBANON AREA FAIR
DEMOLITION DERBY

The Demolition Derby is designed and promoted as an unusual spectator attraction, and in the interest of safety, anyone entering is subject to the following rules and regulations that are hereby set forth by the track where you are competing.

DEMOLITION DERBY RULES

- A. All drivers must fill out an Entry Form and **NOTARIZED** Affidavit before taking part in the event.
- B. The track reserves the right to approve or reject any and all applications.
- C. Only 2 persons (driver and mechanic) that sign the insurance release sheet will be permitted in the pit area or on the track. The rest will be paying spectators.
- D. **NO alcoholic beverages** are permitted on the Fairgrounds. All participants will be inspected.
- E. Only participating Derby Cars will be permitted in the pit area. All other vehicles must be parked outside the pit area.
- F. Only 100 cars will be entered in the Demolition Derby. **CARS WILL BE ACCEPTED ON A FIRST COME, FIRST SERVED BASIS.**
- G. Drivers must be 18 years or older to participate.
- H. All drivers must supply their own car. Entry fee is \$20.00 per car.
- I. When you bring your car to the track, it will be inspected for glass removal, rear seat removal, seat belt installation, battery tie down, type of crash helmet, brakes, and a general workmanship in preparing the car. When the car is accepted for competition, it will be assigned an area in the pit, which is outside the arena.
- J. All non-winning cars from the heat events will be placed in a designated area inside the arena. All winning cars for the feature event are permitted to be worked on in a separate area.
- K. The Fair reserves the right to delay the start of or reschedule the derby due to weather.
- L. All demo cars are to be removed from the fairgrounds within 48 hours of the conclusion of the event.
